**(Correction) Partial Revision to the Support Documentation for the First Quarter
of the Fiscal Year Ending March 31 , 2026**

Support Documentation for the First Quarter of the Fiscal Year Ending March 31, 2026, which were announced on August 7, 2025, have been partially revised, so we will inform you as follows. Corrected parts are underlined in red.

【Reason】

It was found that part of the disclosed information contained inaccuracies.

1. Consolidated Financial Results for the First Quarter of the Fiscal Year Ending March 31, 2026

- Orders:	Orders increased by ¥3,193 million (up 6.1% YoY) , primarily driven by a recovery in domestic civil engineering projects.
- Net sales:	Net Sales rose by ¥10,517 million (up 32.7% YoY), supported by steady progress on a large volume of carried-over construction projects, particularly in warehouses, factories, and multi-family residential buildings.
- Profits:	Gross profit increased by ¥1,113 million (up 38.5% YoY), reflecting both higher sales and improved gross profit margins. Selling, general and administrative expenses rose by ¥542 million (up 23.1% YoY), mainly due to increased domestic labor costs and higher provisions. Nevertheless, operating profit, ordinary profit, and net profit for the quarter all showed year-on-year growth.
